

This is being made amply clear to all the members, who have not yet paid their dues, will be subjected to interest from the date of respective demand and these members in absence of their any outstanding from them, it may not be possible for the Society to purchase land for their share and hence they will not be eligible to participate in land-pooling policy under MPD-2021 in case the dues are not cleared immediately.
